
## Online Registration for 2<sup>nd</sup> Spot Counselling Academic Year 2020-21

Guidelines for the candidates regarding online 2<sup>nd</sup> spot counselling for admission in **B.Tech./M.C.A./M.Tech. - 1<sup>st</sup> Year and B.Tech.-2<sup>nd</sup> Yr. (Lateral Entry)** courses of B.T. Kumaon Institute of Technology, Dwarahat. The candidates are advised to follow the following steps for reporting and counselling:

**Online Registration will be from 19<sup>th</sup> November, 2020 to 22<sup>nd</sup> November, 2020.**

### Step-1

- Candidate visit to Institute website <http://www.keccua.ac.in>
- Deposit counselling processing fee Rs. 1000/= (non refundable) through the link or by Bank Challan given below:

### Step-2

- After depositing counselling processing fee, candidates fill the registration form and upload relevant documents\* through the given relevant link for verification:
  1. JEE (Main) Admit card, if applicable
  2. JEE (Main) Score/Rank card, if applicable
  3. 10<sup>th</sup> and 10+2 mark sheet and certificates
  4. Category certificate along with domicile certificate, if applicable
  5. EWS certificate, if applicable
  6. Sub-Categories certificates like, Armed Forces (AF), Freedom Fighter (FF), Physically Handicapped (PH) etc.
  7. Domicile certificate for state quota
  8. Income certificate issued by competent authority not below the rank of Tehsildar (for TFW seat allotted candidates)
  9. Last Semester Marksheets of Diploma (For Lateral Entry)
  10. Final Year Marksheet (Only for M.Tech/MCA Students)
  11. Photo identity card (issued by Govt. agency/Aadhaar Card)



**Step-3: Counselling and Seat allotment**

- After online registration, the uploaded documents will be verified\*\* and seats will be allotted by the institute counselling committee 2020 as per the preference filled by candidates and availability of seats.
- Allotted candidates list will be published on institute website and candidates have to deposit institute fee through given online link or through bank challan within specified date in order to confirm their provisional admission.

**Step 4: Uploading of institute fee receipt**

Candidates upload institute fee receipt generated through SBI collect or bank challan receipt obtained from bank after fee deposition to given below link.

***\*\*However this registration will be completely provisional, physical verification of all the original certificates/documents is mandatory. The candidate has to verify their original documents when they will be called physically in the institute, in case any information found to be incorrect at any stage of the admission process, candidate's admission will be cancelled.***

**NOTE:**

1. Any candidate may participate in counselling for admission in B.Tech-1<sup>st</sup> Year who having JEE MAINS-2020 rank.
2. Candidates already got provisional admission to BTKIT Dwarahat through counselling conducted by UTU, Dahrhadun or BTKIT Dwarahat and interested for up gradation of their branch must participate in 2<sup>nd</sup> spot counselling.
3. In case of upgradation, if new seat allotted, then previous allotted seat will automatically gets cancelled and that seat will be allotted to others. So already provisionally admitted candidates are advised that they must fill choices very carefully, only the choices which are higher in merit than already allotted branch.
4. If no new branch is allotted to up gradation of branch students, their previous allotted branch will remain same.
5. All lateral entry candidates whose result is awaited, they are informed that in any case they have to submit their Pass Diploma results at least 15 days before the final examination of 3<sup>rd</sup> semester. Failing to that the admission will get automatically cancelled.
6. After filling the required information like choice, category, subcategory, JEE (main) rank and region etc. submit it and take a printout for future reference.

  - I. For state reserve category seats, candidates must have either 10+2 exam passed through Uttarakhand or they must have the Uttarakhand domicile certificate.
  - II. Armed force seat is for Ex Service man. Its certificate should be issued by soldier's board.
  - III. All documents must be issued by competent authority.
  - IV. TFW seat annual income of the family from all sources should be less than 4.5 Lakhs, issued by DM/SDM/Tahsildaar
  - V. EWS seat the annual income of the family from all sources should be less than 8 Lakhs and certificate issued by DM/SDM/Tahsildaar in prescribed format.
