Instructions for B. Tech. / B.C.A. First year students regarding the reporting and room allotment in Gomukh Hostel (Boys)

- (1) All the newly admitted B.Tech./B.C.A first year students (boys) will be allotted room on "First Come First Serve" and sharing basis (03 in a room) in the Gomukh Hostel, BTKIT Dwarahat. The bed/cot will be provided by the hostel. Bring your own bed sheets, pillow, mattress, blanket, bucket, mug, hangers etc.
- (2) For the allotment of hostel you may directly reach the hostel after that make proper entry of your arrival in the hostel in the register kept with the security guard at the hostel and then report to the hostel/ mess clerk (Mr. Prakash Singh, Contact No.: 8395031332) or to Mr. Gopal Singh (Contact No.: 9761248451).
- (3) The room in the hostel will be allotted only after the full payment of the mess advance fee of Rs. 22000/- for the odd semester of academic session 2025-26. One must be note that the mess is operated by the mess committee of students. The extra expenditure will be collected and in case of less expenditure, the money will be refunded at the end of the academic year.  - (iii) Self-attested photocopy of aadhar card of the student.
