<u>Instructions for B.Tech./B.C.A.First year students regarding the</u> <u>reporting and room allotment in Yamnotri Girls Hostel (Girls)</u>

All the newly admitted students(Girls) in B.Tech./B.C.A., session2025-26 are hereby informed that room in hostel will be allotted on17 August 2025. The rules/guidelines/flowchart for hostel allotment are as follows:

- (1) All the newly admitted B.Tech./B.C.A first year students (Girls) will be allotted room on First Come First Serve and sharing basis (03 girls in a room) in the Yamnotri Hostel, BTKIT Dwarahat. 1cot, 1 chair, 1 table, 1 almirah will be provided by the hostel to each student. Bring your own bed sheets, pillow, mattress, blanket, bucket, mug, hangers etc.
- (2) For the allotment of hostel you may directly reach the hostel, make proper entry of your arrival in the hostel in the register kept with the security guard at the hostel gate and then report to the hostel care taker(Mrs. Chandra(8954212986) or Mr.Chandan (7252017825) or Mr. Pankaj(9997883769) or Warden Mrs. Beena Lohani(9568079487) or Warden Dr. Archana Verma(9457894800).
- (3) The room in the hostel will be allotted only after the full payment of the mess advance fee of Rs. 22000/- (Twenty two thousand rupees only) for the odd semester of academic session2025-26. One must be note that the mess is operated by the mess committee of students. The extra expenditure will be collected and in case of less expenditure, the money will be refunded at the end of the academic year. The fee maybe deposited through cheque/ DD (in favour of Yamnotri Hostel Mess), online banking, UPI etc. No cash deposit in the hostel/bank is permitted. - (4) Submit the following documents to the hostel staff on the day of hostel allotment. The documents should be strictly in the order as given below:
 - (i) Duly filled and signed Hosteller Personal Information Form (AY 2025-26) and other forms. These forms/documents are given at Annexure 1(Page no.3), Annexure 2(Page no.4) and annexure 3 (Page no. 5) in this file.
 - (ii) Seat allotment letter of the Institute given to you at the time of admission.
 - (iii) Self-attested photocopy of aadhar card of the student.
 - (iv) Self-attested copy of the print out of the mess advance fee deposited. Amount, account no. (Both debit and credit), transaction number and date etc. should be clearly visible on the print out. Write your name, father' name, branch and contact number on the front side of the printout.
- (5) The appointed staff will check the documents and allot the room if all documents are found in order.
