B. Tech 2nd Year (Lateral Entry) M. Tech. 1st Year and M.C.A. 1st Year Spot Counseling 2022-23 to various disciplines of **Bipin Tripathi Kumaon Institute of Technology, Dwarahat** for vacant seats after the online counseling and dropouts will be held on 8th and 9th Sept 2022 at **BTKIT Campus , Dwarahat**, as per the following schedule:

- 2) Date of counseling (for (B.Tech. 2nd Year (LE)/M.Tech./M.C.A.1st Year): 9th Sept. 2022 (10:00 A.M. onwards) (Only for those candidates who have reported on 8th Sept. 2022)

IMPORTANT INSTRUCTIONS

- The seats are limited. Please check the availability of seats on the website www.kecua.ac.in regularly. The seats shall be filled as per the norms of Uttarakhand Government.
- Merely reporting at spot counseling does not guarantee counseling and admission.
- Cash will not be accepted. Candidates are advised to arrange DD in advance/ Online Payment .
- The candidates are required to come prepared with all documents as listed above.
- Counseling will be continued only up to the availability of the seats.
- Since, the counseling will be held on next day of reporting, the candidates are advised to make their own arrangements for boarding and lodging.
- Already admitted candidates must report with DD of Rs.2000/- (non-refundable) and produce earlier admission letter at the time of counseling for upgrading the branch.

Admission Procedure through spot counseling

Admission to vacant seats of B. Tech 2nd Year (Lateral Entry), M. Tech. 1st Year and M.C.A. 1st Year shall be done as per the following procedure:

- A. Reporting: The candidates desirous of seeking admission must report at the reception counter of the counseling venue on the reporting day i.e. on 8th Sept. 2022. They are required to fill the particulars in the register and collect the required forms.
- B. Processing Fee Deposition: The candidates are required to deposit the processing fee of Rs.2000.00 (non-refundable) in the form of Demand Draft drawn in favour of Director, BTKIT, Dwarahat, payable at SBI KEC Dwarahat (Branch code: 10584). This fee is non-refundable under any circumstances.
- C. Documents Verification: After completion of steps A & B, the candidates are required to join the queue at documents verification counters. Candidates are required to submit one Set of documents and show the originals of the submitted documents.
- D. Counseling: All the reported candidates shall be called to appear before the admission committee in order of merit of UKSEE 2022 Rank / percentage of qualifying examination for the allotment of vacant seats or seats vacant from the left out and the seats to be vacated during up-gradation. The candidate will be denied counseling, if all the seats are filled before his/her turn. Seat allotment letter shall be issued to the candidates, who accept the seat from amongst the available seats at his/her turn. The candidates, who do not accept any seat, are advised to leave the counseling venue.
- E. Admission: The candidates, who have been issued seat allotment letter by the admission committee, are required to complete the admission procedure alongwith the submission of the Institute fee and are advised to report immediately after admission as the session has already been started.
- F. The admission criteria for M.Tech programmes:
 - i) On the basis of valid GATE score for GATE qualified candidates
 - ii) In case of unavailability of GATE qualified candidates, admission shall be on the basis of merit of UKSEE 2022.
 - iii) Further, the seats remain vacant after above steps the admissions shall be on the basis of merit of percentage of B.Tech .
