

Instructions for B. Tech. / B.C.A. First year students regarding the reporting and room allotment in Gomukh Hostel (Boys)

All the newly admitted students (Boys) in B.Tech./B.C.A., session 2026-27 are hereby informed that room in Gomukh hostel will be allotted on 16 August 2026. The rules/guidelines/flowchart for hostel allotment are as follows:

- (1) All the newly admitted B.Tech./B.C.A first year students (boys) will be allotted room on “First Come First Serve” and sharing basis (03 in a room) in the Gomukh Hostel, BTKIT Dwarahat. The bed/cot will be provided by the hostel. Bring your own bed sheets, pillow, mattress, blanket, bucket, mug, hangers etc.
- (2) For the allotment of hostel you may directly reach the hostel after that make proper entry of your arrival in the hostel in the register kept with the security guard at the hostel and then report to the hostel/ mess clerk (Mr. Prakash Singh, Contact No.: 8395031332) or to Mr. Gopal Singh (Contact No.: 9761248451).
- (3) The room in the hostel will be allotted only after the full payment of the mess advance fee of Rs. 22000/- for the odd semester of academic session 2026-27. One must be note that the mess is operated by the mess committee of students. The extra expenditure will be collected and in case of less expenditure, the money will be refunded at the end of the academic year. The fee may be deposited through cheque/ DD (in favour of Gomukh Hostel Mess), online banking, UPI etc. No cash deposit in the hostel/ bank is permitted. - (4) Submit the following documents to the hostel/ mess clerk (Mr. Prakash Singh, Contact No.: 8395031332) or to Mr. Gopal Singh (Contact No.: 9761248451). The documents should be strictly in the order as given below:
- (i) Duly filled and signed Hosteller Personal Information Form (AY 2026-27) and other forms. These forms/documents are given at Annexure 1 (Page no.3), Annexure 2 (Page no.4) and annexure 3 (Page no. 5) in this file.
 - (ii) Seat allotment letter of the Institute given to you at the time of admission.
 - (iii) Self-attested photocopy of aadhar card of the student.
 - (iv) Self-attested copy of the print out of the mess advance fee deposited. Amount, account no. (Both debit and credit), transaction number and date etc. should be clearly visible on the print out. Write your name, father' name, branch and contact number on the front side of the printout.
- (5) The mess clerk (Mr. Prakash Singh, Contact No.: 8395031332) or Mr. Gopal Singh (Contact No.: 9761248451) will check the documents and allot the room if all documents are found in order.
- (6) After the allocation of room in the hostel, fill the Google form. The link or QR code of the Google form is given below: <https://forms.gle/M5yBiGZd1nsVWDXH9>



- (7) You are advised to complete all the formalities mentioned in point (4) before reaching the hostel for smooth hassle free and quick allotment of hostel room. You are also advised to report in the hostel from 9:00 AM to 5:00 PM. In case you are reaching the hostel beyond the above said timings you must contact to above mentioned people before your arrival.

9. I shall vacate the hostel and hand over possession of my room within two days from the last date of my examination of each semester.
